- iii. In the event of breach of this clause, M/S Faiz Scientific Company. shall be liable to pay damages to the SINDH BANK and indemnifies the SINDH BANK against any injury arising out of any breach of this clause by the SINDH BANK.
- iv. This clause shall also survive after termination of this Agreement.

16. INDEMNIFICATION.

i. - 20. A party may change its address for notice by giving a notice to the other Party in writing of such change.
