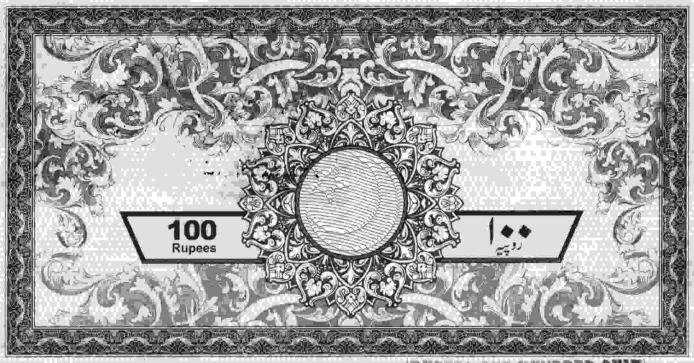

AND

SINDH BANK LIMITED, a banking company incorporated under the laws of Pakistan and having the Head office at 3rd Floor. Federation House, Abdullah Shah Ghazi Road, Clifton, Karachi-75600, Pakistan. (Hereinafter referred to as "THE BANK", which expression shall be deemed to mean and include its successors-in-interest and assigns) of the Second Part.

WHEREAS:

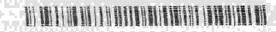

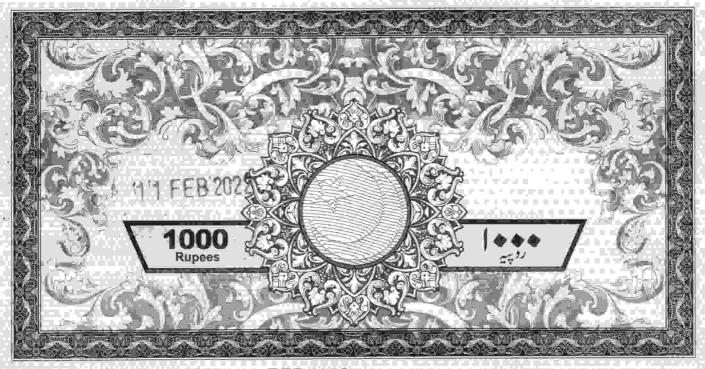
