

1. The "M/s. Jaffer Business Systems Private limited" will provide performance security in the form acceptable to the Sindh Bank for the 10% of the order value for the period of one year from the date of Submission of performance security. In case "Jaffer Business Systems Private Limited" does not fulfill its commitments the Sindh Bank reserves the right to enforce performance security.

All terms & conditions of the tender documents are part of this agreement.

2. The maintenance contract will be end on 31st Oct, 2024, and subsequently can be extended for further three years on mutual consent.

3. The "M/s. Jaffer Business Systems Private limited" shall supply Goods as per specifications and upon the recommendations of the Technical / Standardized Committee appointed by the Sindh Bank within 04-06 weeks from the date of receipt of the Purchase Order.

4. The Sindh Bank will have the option to enforce the performance bond on happening of any one or all the following events.

Jaffer Business Systems Private limited and its Personnel shall not at any time communicate to any person or entity and confidential information acquired in the course of the Services, nor shall M/s. This clause shall also survive the termination of this Agreement.



16. Ensuring Access to SBP:

M/s. Jaffer Business Systems Private limited and SINDH BANK will ensure that the State Bank of Pakistan is provided with necessary access to the documentation and records in relation to the outsourced activities and the right to conduct on-site to **M/s. Jaffer Business Systems Private limited**, if required.

17. Termination of Agreement by the Sindh Bank:

- 4. If issued two (2) warning letters /emails by Sindh Bank Ltd for the unsatisfactory current performance of "M/s. Jaffer Business Systems Private limited".
- 5. Any notice, request or consent required or permitted to be given or made pursuant to this agreement shall be in writing. Any such notice, request, or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent to such Party at the given address.
- 6. A party may change its address for notice by giving notice to the other Party in writing of such change.
- 7. The "M/s. Jaffer Business Systems Frivate limited" will not assign its job to anyone, except with prior written permission from the Sindh Bank.

18. Authorized Representative:

Any action required or permitted to be taken, and any document required or permitted to be executed under this agreement by the Sindh Bank or the "M/s. Jaffer Business Systems **Private limited**" may be taken or executed by the authorized officials.

19. Goods Faith:

The Parties undertake to act in good faith with respect to each other's rights under this agreement and to adopt all reasonable measures to ensure the realization of the objectives of this agreement.

20. Conflict of Interest:

The "M/s. Jaffer Business Systems Private limited" shall hold the Sindh Bank's interests paramount, without any consideration for future work, and strictly avoid conflict with other assignments or their own corporate interests.

21. Anti-Money Laundering Requirement:

"M/s. Jaffer Business Systems Private limited" acknowledge that they do not violate any statutory/prudential requirement on anti-money laundering or record-keeping procedure as per existing laws/rules and regulations of locals as well as foreign jurisdiction.

22. Governing Law Jurisdiction:

This Agreement shall in all respects be constructed and be governed in accordance with the Laws of Pakistan and both the parties i.e. THE SINDH BANK and "**M**/s. Jaffer Business^{FF} Systems Private limited", hereby submit to the jurisdiction of the local courts in Karachine in any legal proceedings and as regard any claims or matter relating to this Agreement.

23. Force Measure:

Neither party shall be liable for any failure to perform or observe its obligations under this Agreement if such failures or delays are caused by acts of God, wars, riots, strikes, accidents, explosion, fire, shortage of labor or materials, labor disputes, government restrictions, or any other cause beyond its reasonable control. In the event of the occurrence

of any of the foregoing, the date of performance shall be deferred for a period of time equal to the time lost by reason of the delay. The affected party shall notify the other in writing of such events or circumstances promptly upon their occurrence.

24. Settlement of Disputes:

- The Parties agree that the avoidance or early resolution of disputes is crucial for smooth execution of the Agreement and the success of the assignment. The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with the Agreement or its interpretation.
- 2.
