AGREEMENT FOR SUPPLY & INSTALLATION OF SIGNBOARDS

THIS AGREEMENTis entered into at Karachi

On this the 18 day of Sept, 2025

BETWEEN

M/S. ADVISION Sign's Pvt Ltd,private Concern, having its principal place of business at Plot No.14 Street No. I-A, Sector (B) Area,near Graveyard Qayyumabad, Karachi (hereinafter referred to "Supplier", which expression shall be deemed to mean and include its successors-in-interest and assigns of the First Part;

AND

SINDH BANK LIMITED, a banking company incorporated under the laws of Pakistan and having its Head office at 3rd Floor, Federation House, Abdullah Shah Ghazi Road, Clifton, Karachi-75600, Pakistan. (Hereinafter referred to as "THE BANK", which expression shall be deemed to mean and include its successors-in-interest and assigns) of the Second Part.

WHEREAS:

"THE BANK" intends to acquire the services of "Supplier" for Supply & Installation of Signboards (goods) for its 10 Branches and Supplier agrees to provide the services to "THE BANK",, as per tender opening date 24/06/2025, along with detail of descriptions and Price Schedule mentioned in Financial Proposal at a total cost of Rs.47,030,00/-which is attached herewith and marked as Annexure-A:


The terms and conditions are as follows:

1) Terms & Conditions:

- a) All terms and conditions of the tender document will remain part of this agreement.
- b) A prior notice of 10 days will be given for the supply and installation of requisite supplies and it will be expected within 04 days, the said supplies will be made available at the site.
- c) Supplies will be required to be given after 30 days of award of contract. Subsequent supply will be required within ten days of issuance of purchase order. In case of failure to supply & installation of signage at site after 50 days the tender will stand cancelled.
- d) The Supplier shall supply the said goods as per specifications of the tender within 04 days from the date of issue of Purchase Order by the Bank.
- e) A fine of Rs 5,000/- per day will be charged, if even after 05 days of issuance of Purchase order, the supplies are not provided, installed and made operational till the requisite is completed.
- f) In the event of the default on the part of the Supplier, in the performance of any condition of the contract/tender or delay in supply of the items even after a lapse of 10 days of the issuance of the purchase order, it shall be lawful for the Bank to forfeit the performance security and cancel the whole part of the supply order or cancel the contract. Decision of the Bank will be final and will be legal binding on the Supplier.
- g) Supplier agrees to maintain adequate inventory of the goods so that the replacement is available within 24 hours, if any fault arises in the goods supplied during the warranty period. In case the effected part is not available, then the Supplier will provide the backup of the same product/item or better till the resolution of the fault is met, without any extra cost to the Bank.
- h) The Supplier also undertakes to bear all kind of taxes i.e. Stamp duty/ Services Charges/Professional Tax / Sales Tax Invoice, Income Tax, Zila / Octroi Tax (if any) and all other incidental charges etc, up to the place of destination.
- The Bank reserves the right to test/check the goods to ensure that it is provided as per specification in the tender document. For any discrepancies, at the time of supply or later, the Bank reserve the right to forfeit full performance security and cancel the tender and initiate the process for blacklisting of the Supplier. The decision of the Bank shall be final and binding upon the Supplier.
- Delivery will be made by the Supplier at different locations prescribed by the Bank.
- k) The cost must include all taxes, installation, labor including delivery charges upto the branches of the Bank on countrywide locations.
- I) Supplier binds/undertakes that in case of any observation arising in respect of quality/performance of the goods within the warranty period, the supplier will be liable to address it at his own cost within 24 hours. Non-compliance of the same will result into initiation of a case against the supplier company for non-commitment and forfeiting of performance security or any other action as deemed necessary.
- m) Any notice, request or consent required or permitted to be given or made pursuant to this agreement shall be in writing. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent to such Party at the given address.
- n) A party may change its address for notice by giving a letter /notice to the other Pa of such change, at the time of said occasion.

p) This agreement is valid for a period of one year commencing from _ and may be extended till the supply of all tender items.

2) Warranty

Warranty of 5 years (For replacing of supplied material/goods on Free of Cost basis, in case of any complaint in respect of quality at later stage) from reputed graphic manufacturer / authorized sole distributor for Panagraphic Signage, Vinyl and ACP, ATM Signboard, Aluminium Composite Sheet, Front Lit Sign Board, as per Scope of Work of Tender Document.

3) Payment Schedule:

- Bill will only be processed on the basis of following conditions:-

 - Due certification that the material has been purchased from b. Authorized sole distributor.
- if the obligation of warranty period are not met or delayed, the repair etc. requirement on this account will be carried out by the bank & the billed amount will be deducted from the performance security/ upcoming payment due to supplier. 4) Performance Guarantee:

5) Authorized Representative:

6) Termination of Agreement by the Bank:

a) If the Supplier, in the judgment of the Bank has engaged in corrupt or fraudulent practices in competing for or in executing the Agreement.

b) If, as the result of Force Majeure, the Supplier is unable to perform a material portion of the Services for a period of not less than thirty (30) days; and

c) If the Bank, in its sole discretion and for any reason whatsoever, decided to terminate this

d) If two (2) warning letters/email are issued by the Bank for unsatisfactory current performance.

7) Goods Faith:

The Parties undertake to act in good faith with respect to each other's rights under this agreement and toadopt all reasonable measures to ensure the realization of the objectives of this agreement.

8) Settlement of Disputes:

The Parties agree that the avoidance or early resolution of disputes is crucial for a smooth execution of the Agreement and the success of the assignment. The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with the Agreement or its interpretation.

If Parties fail to amicably settle any dispute arising out of or in connection with the Agreement within (10) days of commencement of such informal negotiations, the dispute shall first complaint redressal committee of the bank and if parties could not reach at amicable situation, then the matter will be referred to the grievance committee of Bank and if matter could not be resolved the matter will be referred for arbitration of two arbitrators, one to be appointed by each party, in accordance with the Arbitration Act, 1940. Venue of arbitration shall be at Karachi, Pakistan and proceedings of arbitration shall be conducted in English.

10) Conflict of Interest:


