





2. PROVISION OF GUARDING SERVICES TO BE PROVIDED BY:

- 2.1 Will provide and ensure in all branches/premises the deployment of guards in Sindh & Baluchistan, Punjab, Capital Territory, AJK, KPK & Gilgit Baltistan provinces.
- 2.2 Initially the deployment will be carried out in 15 branches. The deployment plan is attached as Annexure 'A'. The deployment dates for remaining branches, in multiple of 10, will be issued subsequently, after due satisfaction and due assurance of compliance of conditions as given in the Tender Document. Failure to abide by the Tender obligations at any stage will render the company disqualified and the agreement will stand cancelled. - 11.5 M/s Parwsest Pacific Security (Pvt) Ltd and SNDB will ensure that State Bank of Pakistan is provided necessary access to the documentation and accounting records in relation to the outsourced activities and SNDB right to conduct on-site to M/s Parwsest Pacific Security (Pvt) Ltd, if required.

14. **DISPUTE:**




